Description

As the Senior Data Analyst for the transformative Environment Online program, you will contribute to the data architecture to advance the program's implementation and adoption. This program offers a unified digital platform for water and environmental regulatory process activities.

This role involves carrying out data initiatives to collect, verify, interpret, analyse, manage and maintain data received from internal and external data sources. This role will also identify opportunities and risks and develop appropriate solutions, along with optimising the unified digital platform functionality, ensuring efficient data process and practices, facilitating effective integration across the Department and industry interfaces to enhance the program's overall impact and success.

Responsibilities

- Undertake and contribute to data architecture activities that inform the development of Environment Online and associated digital systems that enhance effectiveness, efficiency, and accessibility of data and reporting.
- Lead, support, or participate in cross-functional project teams, taking a proactive approach to the achievement of data governance, analytics and reporting.
- Oversee the efficient and effective delivery of the Data stream including data governance, data migration, data analytics and geospatial platform enhancements in alignment with scope.
- Assist in developing reporting standards.
- Extract, review, interpret and analyse data from disparate internal and external data sources utilising different tools, statistical techniques and data management systems.
- Report and interpret information based on data analysis to contribute to research, evaluation, market research, and planning.
- Identify data requirements and resolve data related issues to ensure a sound user experience, consistency and best practices in data management processes.
- Produce Environment Online data documentation including data models, data catalogue, data migration plans, data requirements.
- Provide reports, advice, project updates, training material and other required written documentation.
- Ensure rigorous adherence to DWER policies regarding data governance, data protection and data security.
- Adopt agreed project management methodologies, principles, and templates.
- Work cooperatively and collaboratively with internal and external stakeholders to maintain and effectively manage collaborative working relationships and effective communication networks.

Essential
